## Motor Vehicle Tax Removal/Proration Checklist

CT Department of Motor Vehicles does not inform towns when plates are returned or when vehicles are sold, registered out of state or otherwise disposed of. It is the <u>taxpayer's responsibility to provide the proof for adjustments</u> (prorates) for motor vehicle tax bills within 26 months of the assessment date per Connecticut State Statute (12-71c).
